To avoid any resulting gaps in insurance cover, a special voluntary top-up insurance may be concluded, the premium for which shall be borne by the insured person.

- I am aware that, after withdrawal, the withdrawn sum first has to be repaid in full before I can pay in any voluntary extra contributions - should there be any such provision for voluntary extra contributions in the regulations.
